

Hybrid Work

The return to the office continues to be a controversial topic, with the discussion having shifted from whether it's going to happen, to how it's going to work. With the evolution of employer and employee needs and expectations comes a myriad of questions, considerations, challenges and opportunities. Organizations have an opportunity to not just re-occupy the office but to seize this moment to define a new and better way to work. The pandemic flattened previous cultural and technological barriers, resulting in more people with a choice of where to do their best work. This shift has caused firms to rethink the purpose of the workplace itself. For employees, going to the office is about much more than sitting at a desk and attending meetings - all of which can be done remotely. The future office considers a more holistic approach, creating in-person experiences that make it easy, make it work, and most of all, make it worth it.
